Stage calls for 10 pistol, 10 rifle plus 1 rifle reload, and 4+ shotgun. Order of firearms is pistol, rifle, shotgun. The stage does not state whether the reload can be staged on a prop or not. Shooter stages guns, then takes a rifle reload out of a legally placed rifle loop off the shotgun belt and places it at the rifle position. The shooter then takes 2 shotgun shells out of legal shotgun loops off the shotgun belt and places it at the shotgun position.

ATB, shooter engages pistol sequence correctly, moves to rifle and shoots all 10 rounds correctly, then picks up the 11th round where staged at the rifle position and shoots the last target correctly. Shooter then shoots 3 shotgun targets, misses the 4th target with 4th round, then picks up one of the previously staged shotgun shells and knocks down the last shotgun target.

What's the Call?

Procedural and 2 Misses

- In this scenario, the shooter picked up and "used" the staged rifle round and a staged shotgun shell. The stage instructions did not state the shooter could stage the ammo and it was also not stated in the scenario that it was a "match convention." So using both staged rounds was considered illegally acquired ammo in which the shooter is penalized with a Procedural and since the shooter "used" 2 illegally acquired rounds, then 2 Misses.

Expense and Reward?

I'm troubled. I have agonized for some time now over a comment that was made to me by another cowboy shooter and whether I should post this or not.

Earlier this year I competed in another state's championship match. I've been to this match several times previously and have enjoyed myself immensely. This club puts on a terrific match and this year was no different.

I am not a champion grade shooter and never will be. However, I did do better at this match than at any major match than I have ever done previously. I didn't place first nor did I even place first in my category. Heck I wasn't even in the top 100 of those competing. But I was quite proud of my placement and I did receive an award for placement in my category.

I posted on Facebook about how much fun I had and that I was proud of my results. Many of my Facebook friends congratulated me.

So, what am I troubled about? One of my Facebook friends made a comment about my post. The comment was: "It is a lot of work and expense to attend matches, with little reward!" And yes, that is a quote.

That person is correct in one sense. It is a lot of work and expense to attend matches. There is the work of planning the trip, putting together the ammo, putting together the food (if camping), packing for the trip, making sure that all the guns are in working order and that the vehicle is ready for the trip... I'm sure there is more, but you get the idea.

There is also the expense of buying and maintaining the guns. Also, buying and maintaining the backups. Paying the entry fee and purchasing fuel for the trip. Sure these all add up and yes, it is expensive.

What bothers me? It is the "...with little reward" comment. Sure, I didn't win the match. I didn't even come close to winning the match. But there is plenty of reward. I knew going into this game that it would be expensive. I knew that there wasn't a brand new luxury car or \$100,000.00 prize money for the winner. I knew that the only "reward" would be to say "I did it."

For this particular match I was able to say that I had my best finish ever and that I had actually shot it clean to boot. I was and am proud of that.

The person who made the comment, as I said, is a fellow Cowboy Action shooter. But I guess it is fair to say that he is a Cowboy Action shooter in name only. This person gave me my first opportunity to shoot a cowboy gun at a practice that was being conducted at his home club. I was received with open arms by the group of people at the practice and I think it is fair to say that I was hooked on the game from the very first shot.

He purports to be a proponent of our game and is in charge of CAS at his home club. There is an event that takes place a few times a year at his club that allows a person to experience several different shooting styles... archery, handgun, rifle, trap, skeet and Cowboy. I have helped at this event for the last several years and I take great pleasure in introducing folks to this great game of ours. He talks up the game to all those who attend. And this from a man who, to the best of my knowledge, hasn't attended even a local match since 2012. I have asked him numerous times to join me at one of the local clubs I shoot at and each time he has turned me down. He has stated that he is responsible for getting CAS started at another club where he is a member and that has monthly matches. And yet he doesn't even attend there.

As to his comment "with little reward", I have to differ. I have made numerous friendships as a result of participating in the game. Some of those friendships feel more like family than casual acquaintances. I have been able to challenge myself to improve and have done so, not only in my shooting, but also in my personal life. As a result of my affiliation with CAS and with the Wolverine Rangers I have taken on several new tasks and not all of them have anything to do with CAS. I have seen the generosity and friendship of almost every cowboy shooter no matter where I compete whether it is in Michigan, Indiana, Ohio or California.

So, is there "little reward" to be had? My answer is: it depends on what kind of reward you are seeking. If you are looking for financial gain or any notoriety other than by your peers in this game then you are never going to find it. On the other hand, if you are looking for friendship, encouragement and camaraderie as your reward, then you don't have to look very hard to find it.

Thoughts from the July RO class

On July 21 RO I and RO II classes were conducted in Fenton. Below are some of the reactions from those who participated.

My experience with my first RO class

Just want to thank the Wolverine Rangers for the RO class they put on at the Fenton Lake Sportsmen Club on July 21st. This class was put on by Outrider Outlaw and taught by Cheyenne Culpepper. Although I have been participating with cowboy action shooting off and on since 1996 I had not taken an RO class before. Shame on me.

It cannot be expressed enough the importance of such a course/training in our sport. As a shooter, as a member of SASS, and the Wolverine Rangers it really is a responsibility to know safety, the rules, and having a positive attitude in this sport we are blessed to enjoy. Safety is paramount as we all want to make it home in one piece after a match. A number of scenarios were brought up in regards to assessment and awareness of the shooter at the loading table, firing line, and unloading table including discussion on the 170° rule. Mental state and attitude to costuming and hardware were discussed at length. Reviewed certain stage safety awareness like target placement along with T.O., spotter, and spectator positioning. Really much more than I can write. With rules there needs to be consistency in that application to make the sport fair to all competitors. This was emphasized with not only making a shooter and others safe, but helping condition a shooter from the local match to the big league events like state, regional, national, and world championship matches. Whether it be how the rules are ap-

plied or cadence of "Shooter Ready...Stand By...beep" it's designed to make matches consistent from one event to another no matter where you go state to state or abroad. That certainly helps a shooter know what to expect, feel more comfortable, and even confident when visiting other venues knowing that variances will be minimal when it comes to rules and how a match is run. The rules are the rules and they are to be respected and applied fairly for the competition of sport and safety in our community.

Attitude is key to, well...everything! SASS is no exception. From shooter to Match Director a positive attitude truly makes for an experience that keep people coming back. The course really opened my eyes to the various responsibilities our timing operators, spotters, posse leaders, score keepers, and expeditors have in working a stage as smoothly as possible, as safely as possible, and all while dealing with the various nuances each shooter brings with them to the firing line. It also gave me an understanding of the depth of the work that goes into coordinating and the effort that goes into the jobs of Range Director and Match Director. Coordinating the right people, with the right competency, and with the right attitude. It's an incredible responsibility they all have in making us enjoy our day.

In a nutshell it's highly recommended you take time to attend an RO class – maybe attend a couple times every year or so. There were some folks there like myself attending our first class, but there were quite a few others taking this as a refresher. It definitely will help you up your game while also being in a position to give a little back to the sport in helping others. Looking forward to applying what I have learned.



I attended RO1 and RO2 for the first time this year when it was offered in Fenton. I attended to learn more about the rules and calls so that I can be a better shooter, better participant, and as safe as possible at SASS events. I certainly gained information to help with all of those goals. I found the instructor to not only be very knowledgeable with the rules, but also truly cared to make the sport as fun and fair as possible for everyone. Also, the facility was definitely very nice for this type of class.
